At First Christian Church, we understand the spiritual benefits of the Internet and the tremendous ministry opportunities afforded by its use. We also understand the importance of respecting and protecting your privacy. When visiting our web site we may collect many types of information such as personally identifiable information (including but not limited to: name, address, e-mail address, telephone number, zip code, birth date, gender, etc.), billing and payment information (such as credit card information) if you are making payments online, referring URL, your browser, operating system, IP address, and viewing patterns. We may place a "cookie" on your computer, which contains no personally identifiable information, but is used to recognize you when you visit our site. You can read more about cookies below. This Privacy Policy discloses what information our website collects and what we do with it.

// Information Collected and How it is Used

First Christian Church collects two types of information when you visit our web site:

1. Personal Information – This is information that you voluntarily supply to us through email or the discoverychurch.com website. It is information that you provide us for such things as prayer requests, online contributions or purchases, volunteering for Discovery, etc. Personal information includes but is not limited to name, address, telephone number, e-mail address, zip code, birth date, gender, and credit card information. All personal information is kept confidential and only used to complete the activities you initiate online (such as purchasing a product, registering for an event, etc.). Your personal information is not distributed, sold, or shared with anyone for commercial purposes. We may occasionally use your information to notify you via email of important Discovery news, events or services. We may also share your information in rare cases in which we are required to do so by court order.
2. Technical Information – This is information that is exchanged between our computer and yours when you visit our website. This information is anonymous and cannot personally identify you. This type of information includes but is not limited to your IP address, referring URL, type of Web browser, browser display settings, and whether you are a first time visitor or returning visitor to the site. The technical information gathered from those visiting our site allows us to improve the usability of the website and reduce the number of problems that may occur when viewing our site.

// Cookies

Cookies are small pieces of information that are stored on the user's hard drive containing information about the user. They are used to allow web servers to recognize the computer used to access a web site. They allow fcedmond.org to simplify subsequent visits and to enhance your personal experience in using our web site. Most computers are set up to automatically receive cookies. However, you can prevent cookies from being placed on your computer by going to your web browser's preferences menu. Cookies are not used to gain any personal information about you.

Any information that First Christian Church collects and that you provide is strictly used to extend the ministry of our church. We DO NOT sell, lease, or distribute any information to any commercial entities.

The Privacy Policy of First Christian Church does not apply to such third parties and they are responsible for their own privacy statements. Therefore, this web site takes every precaution to protect this information. **For added security, all sensitive financial information is protected by SSL (Secure Socket Layer). We will attempt to notify you as soon as possible if our security system should happen to be breached.**
